I believe the BC POA Board has discriminated against me. I truly believe the governing documents have been selectively enforced. I have repeatedly asked for corrective action. If there is no corrective action action it is my intent to ask both the State and Federal government to investigate this matter as well as a variety of other matters overshadowing our community. The land purchase needs a complete review.

The sadness for me as a long time resident and property owner is the current state of our affairs. Why should I have to file complaints in an effort to force you to treat me in a fair and equitable manner? It says more about the POA Board than it does about me.

If, ultimately, the government decrees that I must tolerate discrimination in my community, we will at a minimum have had a top to bottom review of your policies and procedures. The government will, through discovery, determine whether owners overdue on assessments have been allowed to continue to use the fitness center and the golf facilities and other amenities. The documents appear clear to me, overdue- no use of common areas among other penalties, like not voting.

I am forever the optimist, a complete investigation into this community could be a positive for all of us. I question many actions, such as using my required assessments to pay for our GM to initiate a lawsuit against another property owner. Or, whether we purchased property we already owned or paid taxes on.

I question the caliber of legal advice you as a Board have obtained . I believe there is clear and convincing evidence that you have engaged in deliberate discriminatory behavior and I am prepared to present that I-have been damaged by your actions.

I urge you and your fellow POA Board members to reconsider your decision to deny me and other some number of other owners an opportunity to participate in electing new officers.
